OPEN FORUM

CC AM reported that Buckinghamshire Council is increasingly concerned at the increase in COVID-19 cases.

138/20 Members Interests

139/20 Minutes of the Meeting held on Monday 2 November 2020

The Council agreed that the minutes of the above meeting were correct, and the Chairman will sign them at the next 'proper' meeting.

140/20 Matters Arising

There were no matters arising.

141/20 Councillor Vacancy

Following the resignation of David Armstrong, the relevant vacancy notice was published on the Parish Council notice board on 12 October, the closing date for a request for an election was 29 October. The notice also was sent to the Electoral Services team at Buckinghamshire Council who informed Clerk on 30 October that no one had requested an election and the Parish Council was therefore free to co-opt.

Three residents *[plus one resident after this meeting]* had expressed an interest in being co-opted onto the Parish Council but it was agreed not to co-opt due to the current COVID meeting restrictions and the imminent Parish Council elections. However, if the Parish Council elections are postponed, Councillors will reconsider their decision.

142/20 Planning

a) Planning applications

20/00717/APP: Linden House, Grendon Road, Edgcott Buckinghamshire HP18 0TN

The response from the Compliments and Complaints team at Bucks Council had been reviewed by Chair and Rod Baker and found to contain anomalies and inconsistencies.

It was noted that Bucks Council had opened a Planning Enforcement case to investigate whether a breach of planning control had occurred regarding the removal of hedgerow and trees. As the Parish Council is listed as a complainant for the new enforcement case, it had requested that all information in respect of this matter should be provided for its consideration. No information had been received.

Actions: Clerk to chase documents issued by Planning Enforcements.

R Baker / R Behagg and Chair to put together a response in the January.

b) Planning appeal

Appeal: 20/00068/REF: Land at Edgcott Road and Springhill Road, Grendon Underwood

Outline application with access to be considered and all other matters reserved for a residential development for up to 65 dwellings. 100% affordable housing to be provided.

It was noted that an objection to this appeal had been submitted.

c) It was noted that the marquee in the grounds adjacent to Grendon Road did not have planning permission.

Action : Clerk to follow up.

d) It was noted that hedges had been planted around the fenced off areas in the field between the village hall and Pond Cottages. The owner of the field had approached two residents asking to purchase some of their land to gain access to the field which both refused. However, nothing further was known.

e) It was noted that ground work has taken place in the field on Lawn Hill opposite the wood yard.

Action: Councillors to monitor.

b) 2021-22 Budget

Councillors had reviewed the draft budget and agreed that an increase in the precept should not be made this year. The Precept will be set formally at the January meeting.

It was noted that during discussions for the lease of the hall, the precept was increased over a couple of years to cover the cost of legal fees but had not been reduced since, leading to a build-up of funds.

Action: Clerk to add to the January agenda.

144/20 Potential New Prison

On 3 December the Ministry of Justice (MoJ) notified the Parish Council of "The New Prisons Programme and proposals for a potential new prison in Buckinghamshire". The potential site identified is HMP Grendon / Springhill. Following a meeting between Bucks Council and the MoJ the original consultation deadline has now been extended from 24 December 2020 to 29 January 2021.

The Parish Council is liaising with Grendon Underwood Parish Council (GUPC), and has issued a

leaflet to all households in Edgcott. The leaflet has since been adapted for their use by Grendon Underwood PC. Following a ZOOM meeting with GUPC, a Committee has been set up between GU and Edgcott with Roger Behagg and Cllr Gassor representing Edgcott.

Rod Baker, Roger Behagg and Councillors, continue to review the proposals and will issue further information to the village. It was emphasized that, if the new prison is approved, it will have a huge impact on the locality and that as many residents as possible should send in VALID objections.

Actions:

Rod Baker, Roger Behagg and Councillors to:

- continue to monitor and liaise with target villages including Calvert Green, Marsh Gibbon*, Charndon, Twyford, Quainton and Steeple Claydon.
- Issue regular newsletters (including a picture of the prison being built in Wellingborough) to keep up the pressure on residents to send their objections (the objections must be valid – not just ‘in my back yard’).
- Keep Facebook updated.
- Review the new MoJ document.

Bucks Council is aware that the proposal has another huge impact to an area already blighted by HS2 and EWR.

**It was noted that Marsh Gibbon Parish Council is in favour of the prison if it brings employment to the area and doesn't impact Marsh Gibbon during the construction phase.*

145/20 Village Hall

a) **Improvement update**

Car Park

The car park is almost complete. A delay has been caused by the tardy response from Buckinghamshire Council regarding the Road Space license.

Action: Clerk to liaise with the contractor.

b) **Committee update**

No updates were available.

c) **Vale of Aylesbury Housing Trust Development (VAHT) at Village Hall**

It was noted that the likely completion date is now 22 January 2021.

146/20 Highways and footways

a) **Grendon Road Land**

Parking on Bucks Council land along the Grendon Road still is causing a problem.

Action: Clerk to follow up.

b) **Road Tube Exercise / HGV Survey**

It was agreed to arrange a road tube exercise on Grendon Road and a ‘manual’ HGV survey at the same time.

Action: Clerk to book Road Tube for January 2021.

Chair had sent the results of the Buckingham Road Tube exercise to the Customer Relations Officer - Road Safety, Hampshire Constabulary & Thames Valley Police Joint Operations Unit, which is looking into getting the Enforcement Site Assessment Team to bring a speed camera to Edgcott. All future data from the Road Tube and HGV surveys will be sent to the unit and to Bucks Council to try to get the HGV's re-routed and/or a weight limit introduced.

c) **Speed watch**

It was noted that pressure is being put on Thames Valley Police (TVP) by the Community Board HS2 / EWR sub community to allow Sentinel Camera work to go ahead, as Bedfordshire Police have allowed it to continue.

d) **20's Plenty Campaign**

Once the results of the petition are collated, they will be sent to Bucks Council to lobby for a 20mph speed limit.

Action: Clerk / Chair to follow up.

e) **General Highways**

Drainage work on Perry Hill and Grendon Road together with pavement work on Buckingham Road is still outstanding. Rod Baker confirmed that he had cleared one of the gullies in Grendon Road.

Action: Chair to follow up outstanding work with TfB.

147/20 Street Lighting

It was noted that the street light repairs/upgrade at the corner of Lawn House Lane / Grendon Road and Church Lane will total approximately £1,005 which Councillors approved.

Action: Clerk to authorise the contractor to go ahead with the work.

148-149/20

HS2 / East West Rail (EWR)

Roger Behagg attended a recent ZOOM HS2/EWR Subgroup meeting and reported that the questions submitted prior to the meeting had not been addressed. It was noted that the average HS2 HGV vehicle movement through Edgcott at peak time would be about 75.

It was noted that although the EWR agreement was that there would be no Saturday afternoon and Sunday working, lorries had been coming through the village during this time. He continues to battle with EWR and HS2 to get them to adhere to their own guidelines.

Action: Cllr Gassor to put a note onto Facebook encouraging residents to phone the HS2/EWR helpline to make individual complaints regarding the lorry movements.

149/20 Oxford to Cambridge Expressway

There were no updates.

150/20 Aylesbury Vale Lottery

The lottery continues to generate funds.

151/20 Community Board

Chair attended the 'virtual' Community Board and reported that there were 52 participants, too much emphasis was centred on the Haddenham area and that the small parishes had very little input.

It was noted that Edgcott, Charndon, Steeple Claydon, Calvert Green and Twyford had formed a 'Calvert Box' with one representative from the box attending the larger meetings as very little was getting addressed there.

152/20 Correspondence, Circulars and Consultations

All correspondence, circulars and consultations had been forwarded to councillors by email. Details of emails circulated are at appendix 2.

154/20 Any Other Business

It was noted that some residents had complained on Facebook that they could not log into the meeting.

Action: Cllr Gassor will respond to the Facebook comments and indicate that the minutes will be
