# 127/22 Minutes of the meeting held on Monday 8 August 2022

### 128/22 Matters Arising

#### 129/22 Her Majesty Queen Elizabeth II: 1926-2022

A joint statement from the Parish Council and the Parochial Church Council was issued on 10 September following the death of HM Queen Elizabeth II. It was noted that:

- A book of condolence was available in the church from 10 September and then moved to the village hall on 17 September for a further four days. The Condolence Book was collected by Rev Hiscock after HM The Queen's funeral.
- The Proclamation was read at a church service on 18 September (it was noted that the Parish Council did not have a legal responsibility to read the Proclamation).
- A National Minute's Silence was held in the village hall the same evening.

#### 130/22 Planning (2021-22 Planning applications/decisions are at Appendix 1)

**Planning Appeal Ref: 22/00125/REF** - HM Prison Grendon, Springhill Road Grendon, Underwood BuckinghamshireHP18 0TL

It was reported that the Ministry of Justice has submitted an appeal against Buckinghamshire Council's decision to refuse its planning application. Grendon Underwood and Edgcott Parish Councils and the working group have reformed and are working on their appeal strategy. Council has been advised against invoking Rule 6 status as Bucks Council is against it.

**21/01876/APP** | Change of Use of land for the Creation of 4 Gypsy/Traveller Pitches comprising the siting of 1 mobile home, 1 touring caravan, and the erection of 1 dayroom per pitch | Land Adjacent To Lawn Hill Edgcott Buckinghamshire

**Decision: Application Refused by Bucks Council.** An appeal against this decision was submitted on 29 September. The parish council objected to the initial planning application and will now make additional objections/comments to the Appeals Inspectorate. **The appeal was withdrawn on 13 October.**

# Awaiting a decision by Bucks Council (AVDC Area)

It was noted that:

- an enforcement notice reference 21/00231/CONB 21/00231/EN1 was serviced on various people associated with the land adjacent to Lawn Hill on 9th August 2022.
- Activity on the land continues.
- The Parish Council will continue to report any planning concerns regarding this site to the Planning Enforcement Officer and residents are advised to do the same.

# 132/22 Village Hall

It was noted that there are forthcoming bookings including:

- a pop-up pub (3 December with proceeds to the church)
- church fayre (12 November with tombola)
- coffee mornings in the New Year

Grass cutting arrangements need to be confirmed and will be reviewed after Christmas.

# 133/22 Highways and footways

# The following were noted:

- EWR have confirmed that they are unable to clean out the pond at Pond Corner.
- It was considered that the local work (Marsh Gibbon Road, Shipton Lee) has been completed satisfactorily. It was hoped that Stone Road would be improved to the same standard but only random patching has been carried out.
- The rodding along Grendon Road into the pond has not been completed.
- Work planned to upgrade the electricity power from Waddesdon to the prisons, is likely to take approximately 12 months and cause more disruption to the area with traffic lights on the A41 from January 2023.
- All cultivation licenses in Bucks have been revoked and new licenses issued judged on eligibility.

Action: Chair to contact LAT regarding outstanding work.

# 134/22 Street Lighting

The response to the request for quotes for a new street lighting maintenance contract, following the closure of Aylesbury Mains, was disappointing with only one response from a company in Lenborough which the Council decided to accept. Charles Harris, who monitors the street lighting,

has agreed to get a quote from the Lenborough company for the repair of two street lights which are out of order.

#### 135/22 Speed Watch

# a) Community Speed Watch

No volunteers had come forward.

#### b) Police Speed Check

It was noted that the speed enforcement officers in the village on the 23<sup>rd</sup> August were testing to find a suitable location to carry out a speed enforcement session.

Action: Chair to keep chasing Thames Valley Police for a speed enforcement session.

# c) 20's Plenty

Council has been advised that a 20mph speed limit through the village is unlikely to be approved.

# d) Speed Indicator Device (SID)

A mobile SID has been ordered via the Community Board.

Action: Chair and Cllr BK to have a site meeting to decide where the sockets for the mobile SID should be located and then seek highways approval.

# 136/22 HS2

Roger Behagg (RB), Chair and the Chair of East Claydon Parish Council were given a tour of HS2's West Street compound which they thought looked well organized. RB had asked why the HGV's currently using local roads were not using the access roads built leading into the compound but was not given a convincing answer. It was concluded that they are using local roads "because they can".

#### 137/22 East West Rail

RB continues to chase EWR to progress community projects.

Action: RB agreed to raise the community issues at the next CALM meeting.
