47/20 Minutes of the Meeting held on Monday 9th March 2020

The Council agreed that the minutes of the above meeting were correct, and the Chairman will sign them.

48/20 Matters Arising

There were no matters arising.

49/20 Planning

a) Planning applications

20/00717/APP: Linden House Grendon Road Edgcott Buckinghamshire HP18 0TN
Erection of one detached dwelling with associated amenity space and detached garage
It was noted that the above building work has proceeded without relevant planning permission.
Council and residents have made representation to Buckinghamshire Council regarding this. It was noted that a resident had made representation to the Health & Safety authority regarding the lack of netting under the scaffolding and had been informed that this was not a legal requirement but should be addressed in the builder's risk assessment.

b) Neighbourhood Plan

Chair, Cllr Armstrong and Clerk had joined a video conference with Chair and Clerk of Calvert Green Parish Council and their neighbourhood plan expert to discuss the possibility of forming a Multi-Parish Neighbourhood Area. Following discussion with Edgcott Parish Councillors it was agreed that Chair, Cllr Webster and Cllr Armstrong would join Calvert Green's steering committee. However, Calvert Green have decided to 'go it alone' and not to form a Multi-Parish Neighbourhood Area. Edgcott Parish Councillors have agreed to proceed on their own if there is a guarantee of 100% grant funding for the project as the Council does not have any available funding for the project. It also was noted that if the Council does go ahead, volunteers will be required to form a steering group.

Action: Clerk to contact Calvert Green's Planning Expert to set up a meeting with Councillors to discuss the way forward.

b) 2019-20 Annual Governance and Accountability Return

i) Certificate of Exemption

Council confirmed that it would submit a Certificate of Exemption for the 2019-20 return as the income and expenditure were under £25,000.

ii) Internal Audit

Clerk confirmed that she had held a Zoom meeting with the internal auditor at 10.30 am on Monday 18 May 2020, who had now signed off the accounts.

iii) Section 1: Annual Governance Statement

Councillors agreed the Annual Governance Statement.

iv) Section 2: Annual Accounting Statement

Councillors agreed the Annual Accounting Statement.

c) Funding for VAS

No updates were available.

Action: Clerk to retain VAS funding on meeting agenda.

d) S106 Planning Application 07/01493/APP: Land adjacent to Manor Farm Main Street, Poundon

Buckinghamshire Council had informed the Parish Council that £19,248 S106 money was available from the above development and had asked if it had any projects for which it wished to submit a request for funding.

A request for £10,000 towards the cost of the proposed village hall car park had been submitted.

It was noted that all the villages in the 'Marsh Gibbon Settlement Cluster' (which includes Edgcott, Marsh Gibbon, Poundon, Charndon, Twyford, Grendon Underwood and Calvert Green) had been approached.

51/20 Village Hall

a) Improvement update

i) Car Park

Requests for quotes had been sent out to three contractors but Clerk had not received any response.

Action: Chair and Cllr Kay to liaise to make some changes to and issue the specification to three more contractors.

ii) Damp

It was noted that A Benfield would carry out the repair work on the damp patch.

iii) Birds in the roof

It was noted that action will be needed to prevent birds getting into the roof space.

Action: Chair to speak to A Benfield to get the work completed after the nesting season

iv) Weeding

Chair and Cllr Gassor have this in hand.

b) Committee update

Although there are currently no bookings during the lockdown, it was noted that the village hall is not losing money. It also was noted that the Vale of Aylesbury Housing Trust (VAHT) continues to pay for the utility bills whilst still on site.

c) Vale of Aylesbury Housing Trust Development at Village Hall

A completion date end of August, as previously reported, now seems to be optimistic. Placement of some Heras fencing had been discussed.

Action: Cllr Kay to speak to the VAHT Foreman to agree the location of the fencing.

52/20 Highways and footways

a) **Drainage work**

It was noted that the ditches along the Grendon Road had been cleared but that some jetting still needs to be finished. Chair reported that the Local Area Technician (LAT) has a work order in place to complete this work.

It also was noted that:

- there were still problems with surface water in places;
- work on Lawn House Lane still had not been completed;
- there is a problem with the ditch near Springhill;
- the LAT had placed a work order to clear the gullies in Buckingham Road and Perry Hill.

b) Speed watch

Council continues to receive information from Anna Semlyen, 20's Plenty organiser, encouraging local councils to get together to put pressure on Buckinghamshire Council to introduce a 20mph speed limit. Clerk confirmed that she had asked the Local Area Forum (before it was disbanded) to forward a letter from Edgcott Parish Council to local Parish Councils asking for their support but had not received any feedback.

It was agreed that a speed watch session with the Sentinel Camera would not be carried out during the lockdown.

Action: Clerk to follow up with local Parish Councils

c) **HGV Survey**

It was agreed that an HGV survey should be carried out and to concentrate on a single day rather than spread out for a couple of hours over a few days. It was agreed that a 'Tube' survey should be held at a cost of approximately £400, to assist the HGV survey, but to wait until the schools return.

d) Community Speed watch Sign

Council had not received the Community Speed watch sign.

Actions: Chair and Roger Behagg (RB) will erect the current sign and the new sign when it arrives. Clerk to chase the order for the new sign.

53/20 Street Lighting

Charles Harris, who still is monitoring our street lighting, had prepared a new inventory, which had been sent to Western Power Distribution to facilitate our unmetered supplies certificate being updated. This should reduce the cost of the street lighting electricity.

Action: Clerk to follow up with the contractor.

54/20 HS2

RB reported that he had written to various bodies requesting details of proposed lorry movement but had not received a response from any. However, it was noted that the figures quoted by Cllr Paul Irwin appear to be incorrect.

It was noted that some unmarked HS2 vehicles were coming through the village. HS2 had explained that they did not mark their lorries so as not to attract protesters.

Chair reported that he had sent details of Varney Lorries to Graham Hilary, TfB, to try to get them re-routed away from Edgcott and was awaiting a response.

Action: RB will continue to try to get accurate vehicle numbers.

It was noted that HS2 shortly will be making improvements to the junction at the Broadway and the A41.

55/20 East West Rail (EWR)

No updates were available.

56/20 Oxford to Cambridge Expressway

It was noted that the Oxford to Cambridge Expressway has been 'paused'.

57/20 Aylesbury Vale Lottery

It was noted that the Buckinghamshire Lottery (formerly Aylesbury Vale Lottery) continues to generate funds. It was noted that the income has started to dwindle. Clerk reported that she had issued a cheque for 50% of the income to the PCC.

58/20 AVDC / BCC Unitary Authority (now Buckinghamshire Council)

It was noted that the change to the new Buckinghamshire Council had taken place on 1 April, however elections for the new Council will now take place on 8 May 2021 due to the Coronavirus lockdown. It was noted that the Local Area Forums have been disbanded and replaced by Community Boards. Michael Rand is the new chairman for the area into which Edgcott falls.

59/20 Social Media

The resident who placed the following comments on social media has not clarified his comments nor substantiated his claims as requested.

. I am not getting personal which you obviously are. As a Parish Councillor personal views against individuals and a personal vendetta is not professional. This shows in your responses, so unless you as a parish councillor is wanting to have a civil conversation and debate with one of parishioners I would suggest that cease being unprofessional, you need to show some professionalism in your position. Incidentally we have attended PC meetings and everyone we have there are digs at us and as parishioners that is not professional. Yes I did go forward for a position and stood aside for you, glory or what - no I was wanting to get on to do something good and represent the parishioners and have personal gains need I say what was given the building work at the VH after a parish councillor amended the quote?

Action: Clerk to draft a note for Councillors explaining the situation, which they could put on the Facebook page.

61/20 VE Day Celebrations

Formal VE Day celebrations had been cancelled, although it was noted that some residents had
